
You are aware that CBSE is conducting its annual examinations for classes X and XII from 15th February 2024 to 2nd April 2024. In both the classes, more than 39 lakhs students would appear in India and 27 countries abroad. These examinations would be conducted at a very large scale involving a large number of people. To ensure that examinations are conducted successfully, the cooperation of all the schools and their management is a necessity. There are about 341 schools in your State affiliated to CBSE and the examination of the students of these schools will be conducted in about 114 schools fixed as examination centres. As the Government schools of your state are affiliated to the CBSE, hence, cooperation is required in the following areas:

1. During the conduct of examinations
2. During the evaluation of the answer books.

As the examinations would be conducted for a longer period hence, directions may be issued to the Principal of State Government Schools affiliated to the CBSE to make elaborate preparations for the smooth conduct of examinations. In this regard, the Board will send guidelines to the centre schools shortly on their official CBSE email id. They may also be requested to read the guidelines carefully and thereafter necessary preparations for the smooth conduct of examinations may be made by them at their examination centre.

As an outcome of this examination, approximately an evaluation of 2.25 crore answer books will be done to assess the performance of the students and to declare their results. For the evaluation of the answer books, CBSE will be issuing a "Scheme of Evaluation" to all the evaluation centres. Also, to evaluate answer books correctly, the services of competent and good teachers will be required. Accordingly, principals relieve their teachers for full time as and when appointed by the concerned Regional Office, CBSE, for evaluation.

With your assistance and cooperation, CBSE would be able to conduct the examination 2024 successfully.
