ORDER UNDER SECTION 30 AND 33 OF THE DISASTER  
MANAGEMENT ACT, 2005

Whereas, the conditions of abnormally hot weather generally known as Heat Wave has been observed and reported from the different parts of the district which has the probability to impact the health of the public at large and the India Meteorological Department has also forecasted conditions of Heat Wave in upcoming days ;

Whereas, Heat Wave can increase the hospital admissions for heat-related illness, as well as cardiovascular and respiratory disorders and can trigger a variety of heat stress conditions, such as heat stroke;

Whereas, the schools remain open during the noon hours which increases the vulnerability of the students for the impacts of the Heat Stroke;

Whereas, I am of the view that there is dire need to take preventive measures in order to avoid any emergency situation that may be created by the current situation of Heat Wave;

Therefore, I, Hemraj Bairwa, IAS, District Magistrate, Kangra at Dharamshala, in exercise of the powers vested in me under section-30 and 33 of the disaster Management Act, 2005 and in welfare of the public at large do hereby order and direct that:

1. Opening and closing timings of schools Public or Private, operating within the administrative jurisdiction of District Kangra shall be as under:-
  - Opening Timings:- 7:30 A.M
  - Closing Timings:- 1:00 P.M
2. Schools are advised to not to make any open air activates during this period and proper drinking water be made available to children.

The aforesaid amendments regarding the school timings shall come into force immediately within all Sub Divisions of District Kangra except Dharamshala, Baijnath, Jaisinghpur and Palampur and shall remain valid till further orders;

Compliance to the aforementioned order shall be ensured by the Deputy Director, Higher Education, Kangra, Deputy Director Elementary Education, Kangra and All concerned Sub Divisional Magistrates in District




