

Respected Sir,

In past it is come into the notice that Ex-Servicemen (Specially Clerks/JOA) are being given financial benefits of **Military Service** only for two years which is **unjustifiable**. It is therefore, requested kindly to supply/provide the following informations/documents immediately :-

1. Copy of Ruling/Letter under which an ESM (Clerk/JOA) is authorize for financial benefits of military service for two years only i.e prior to placing on Higher Stage Pay.
2. Copy of Ruling/Letter under which an ESM and Govt employed (Clerk/JOA) of **SAME DATE** are authorized **Equal Basic Pay** on reaching at Higher Stage Pay after Two Years of Regularisation even if ESM's Basic Pay is Less than the Higher Stage Pay. For Example :-

3. Copy of Ruling/Letter under which earlier Pay fixation of an ESM done on regularization can not be re-fixed/revised on reaching at **HIGHER STAGE PAY** while the **Basic Pay of ESM is much Less from the Higher Stage Pay**.
4. Name of PIO/Official/Head who deals such cases with contact No.
5. Reply alongwith authorities/letters should be reached within the stipulated time frame of RTI Act.
