
**SUBJECT:- DISPLAY OF THE UNITED NATIONS FLAG ON THE UNITED NATIONS DAY-REG.**

I AM DIRECTED TO SAY THAT EVERY YEAR 24<sup>TH</sup> OCTOBER IS OBSERVED AS UNITED NATION'S DAY(.) ON THIS DAY, THE UNITED NATIONS FLAG IS FLOWN ALONG WITH THE INDIAN NATIONAL FLAG ON ALL BUILDINGS ON WHICH THE NATIONAL FLAG IS REGULARLY FLOWN IN THE STATES/UNION TERRITORIES(.) THE UNITED NATIONS FLAG IS, HOWEVER, NOT FLOWN ON RAJ BHAWANS/ RAJ NIWASES AND BUILDINGS HOUSING LEGISLATIVE COUNCILS, LEGISLATIVE ASSEMBLIES AND HIGH COURTS(.)

2. IN TERMS OF PARA 3.36 OF THE FLAG CODE OF INDIA, 2002, "WHEN THE UNITED NATION'S FLAG IS FLOWN ALONG WITH THE NATIONAL FLAG, IT CAN BE DISPLAYED ON EITHER SIDE OF THE NATIONAL FLAG(.) THE GENERAL PRACTICE IS TO FLY THE NATIONAL FLAG ON THE EXTREME RIGHT WITH REFERENCE TO THE DIRECTION WHICH IT IS FACING (I.E. EXTREME LEFT OF AN OBSERVER FACING THE MASTS FLYING THE FLAGS)"(.)

3. YOU ARE, THEREFORE, REQUESTED TO ISSUE NECESSARY INSTRUCTIONS ACCORDINGLY IN THE MATTER IN SO FAR AS THE BUILDINGS UNDER YOUR CHARGE ARE CONCERNED(.)


