ORDER

The SLP has been filed by the Department before the Hon'ble Apex Court. After taking legal opinion it has been decided to implement the orders/judgments passed delivered by the Hon'ble High Court qua the pensioners subject to the stay if granted outcome of the SLP: filed by the Department “

It is therefore, keeping in view the above noted considered stand of the Higher Education Department taken up with the prior approval of the law and Finance Department to the State of Himachal Pradesh, the benefit to the State of Himachal Pradesh, the benefit to the petitioners are as under, have been allowed to serve continue till they attain the age of 60 years subject to the final outcome of the SLP (Civil) in the Apex Court having e-filing No. EC-SCIN01-29426-2024 dated 27.08.2024
