Subject: Reg. the PARAKH Rashtriya Sarvekshan – 2024, scheduled on 4th December 2024.

Sir/Madam,

With reference to subject cited above, it is intimated that the **PARAKH Rashtriya Sarvekshan 2024** is scheduled to be conducted on **04.12.2024**, in government and private schools of Himachal Pradesh on sample basis. The sample will be decided by the NCERT, MoE, Gol. The survey is aimed at assessing the learning levels of students in **Grades III, VI, and IX** across all government, private schools. The key features of this survey are as under:-

- It targets students in the foundational (Grade III), preparatory (Grade VI), and middle (Grade IX) stages of education.
- The district will be used as the unit of analysis to ensure a comprehensive understanding of learning levels.
- The survey will focus on assessing the learning competencies outlined in the curriculum for these stages.

Keeping in view the above survey, to ensure the successful participation of all the students, you are directed to instruct all the educational institutions including private schools to initiate rigorous preparation for the upcoming survey and follow the instructions given below:

1. **Review of Competencies:**
Ensure that teachers revisit the key learning outcomes and competencies expected from students in Grades III, VI, and IX.
2. **Practice Assessments:**
Conduct regular practice assessments, aligned with the expected competencies for each stage, to familiarize students with the types of questions and competencies that will be evaluated.
3. **Extra Remedial Sessions:**
Arrange remedial sessions for students who may need additional support to bridge learning gaps before the survey.
4. **Zero Period:**
Dedicate a 45-60 minutes zero period for preparation of PARAKH Rashtriya Sarvekhsan
5. **Teacher Involvement:**
Teachers should focus on competency-based learning and should be actively involved in evaluating the progress of students.

It may be instructed to all the private schools under your control that Samagra Shiksha will assist for preparation of all private schools by providing the following materials in soft copies:




