

Annexure 'A'

Guidelines for "Setting up of Herbal Gardens in Schools"

- The schools should have separate plots to make up an area of 500 sq. m.
 for the setting up of herbal garden and it may be ensured that the herbal
 gardens are made in areas which will not be required for construction
 and the proposed land will not be diverted for any other purpose in the
 future.
- 2. 10-15 species of medicinal plants including tree species may be planted as per the agro-climatic zone and focus should be on Rare, Endangered & Threatened (RET) species of medicinal plants.
- 3. The schools must have boundary wall and irrigation facilities.
- 4. The schools will be responsible for maintenance of the herbal gardens with the active involvement of the students and parent-teacher associations/ NGOs and also make special arrangements during school vacation period.
- 5. Students will be involved in labeling the plants, watering, weeding etc. which will enhance the knowledge of the students about the benefits and uses of the species nurtured by them.
- 6. The material from School Herbal Gardens could be utilized for further propagation.
- 7. An amount of Rs. 7000.00 per school per year will be provided up to four years for the maintenance of herbal garden after the satisfactory utilization of funds to the tune of Rs. 25000.00 per school being released for the setting up of herbal garden (subject to receipt of Grant for recurring expenditure from GoI). The schools will ensure the post project maintenance when the grant-in-aid will be stopped after five years.
- 8. The proper beds (1m width & length as per available space) may be made for planting the plants and the same may be maintained afterwards. Remove all pebbles, non-biodegradable material from the soil bed.
- 9. The plants may be planted with proper spacing for allowing space to grow. The tree species can be planted on the sides/ boundaries.
- 10. The plates may be fixed in the beds thereby providing local name, botanical name, family and uses of the particular medicinal plant.

- 11. The plants may be irrigated immediately after transplantation & thereafter regularly for saving them from drying as per climatic conditions.
- 12. The FYM/ vermi-compost (100-200g/plant or 3-5 kg m²) may be mixed in soil for proper growth of the plant.
- 13.Apply vermin-compost/FYM as per above mentioned dose at least twice a year.
- 14. Weeding & hoeing may be done from time to time to avoid competition to the plant.
- 15. The plants may be checked regularly for diseases or pest attack, if any. Make use of organic insecticide & fungicide, if required.
- 16. Mulching can also be done as per requirement.
- 17. Maintain proper drainage system. Do not allow water stagnation in the beds/field in any case.
- 18. Keep removing diseased & dead parts from the plant.
- 19. Keep field beds raised during monsoon season and sunken while winter & summer seasons.
- 20.Quarterly survival report of the plants may be submitted to the concerned District AYUSH Officers.

The concerned District AYUSH Officers may be contacted for deputing the Ayurvedic Medical Officers from the nearby Ayurvedic Health Centres in the vicinity of school for making students aware about the general uses of the medicinal plants. Also the Project Officer, Research Institute in ISM, Joginder Nagar, Distt. Mandi (01908-222970) may be contacted for any technical support and availability of planting material on cost basis.
