Sir,

This is in continuation of this office letter No. HPPES-SS-MIS-02/2023-XII-1661 dated 21st September, 2024 on the subject cited above. In this regard, it is submitted that a detailed guidelines and instructions received from GoI were shared with your office. Virtual meeting was conducted with the District Project Officer and MIS Incharges. They have further trained Block level Officials. But, the progress revealed that only 3261 schools started generation of APAAR on UDISE+ portal out of 17301 schools and only 9.83% students have generated APAAR ID. In view of that GOI has taken a serious review on APAAR held on dated 12-11-2024. District wise progress is as under:

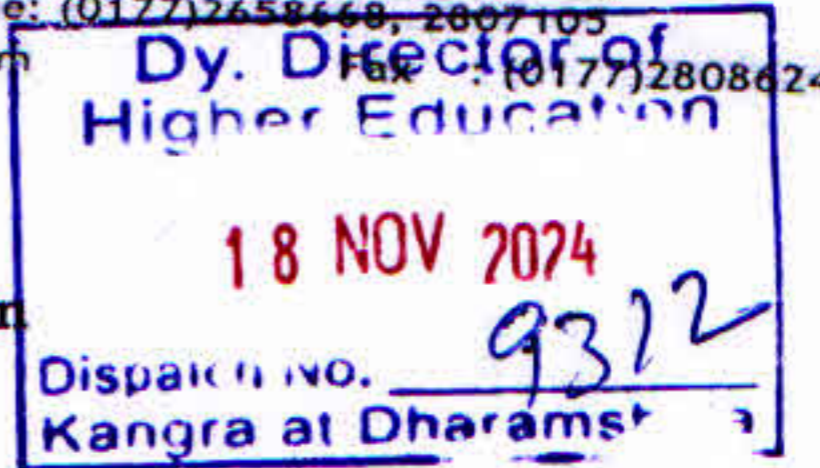


