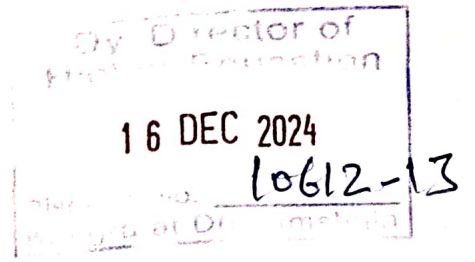




On the above cited subject, as you all are aware that last date for registration and submission of scholarship application by the students under Centrally or State Sponsored Scholarship Schemes for the Academic Year 2024-25 through National Scholarship Portal is on or before 18-12-2024. And, re-submission and re-verification of defective scholarship applications under these Schemes by the applicants i.e. students and their Institutes is on or before 23-12-2024. In this regard, all the applicants and Head of Institutes are advised to ensure the following:-

1. The students who want to apply for scholarship under Centrally or State Sponsored Scholarship Schemes in the current Academic Year 2024-25, are advised to register and apply for scholarship accordingly as per the eligibility of the student's through the National Scholarship Portal on or before 18-12-2024, positively.
2. All the students whose scholarship application has been marked as defective at Institute Level or State Level, will ensure to re-submit their defective scholarship applications through their login ID on the National Scholarship Portal, after making

the necessary corrections and uploading of necessary documents as per scheme guidelines and as per queries raised at L-1 or L-2 Levels within the prescribed time line i.e. on or before 23-12-2024, positively.


3. All the Institutes will ensure to re-verify the defective scholarship applications within the prescribed timelines on or before 23-12-2024, if found in order. It is also be ensured that no scholarship application of any student(s) of their institute remained defective in the Students Login ID as well as Institute Login ID. Pendency of scholarship applications at institute level i.e. L-1 level should be nil. Otherwise, Head of Institution and Institution Nodal Officer Scholarship (INO) will be held responsible for any disadvantage to the eligible applicant.
4. The scholarship application which will remain unattended at Students level will stand deemed rejected after 23-12-2024.
5. The Deputy Directors of Higher Education of all Districts will ensure to verify all the scholarship applications under Centrally Sponsored Pre-Matric Scholarship Schemes within the prescribed timeline. Instructions in this regard to all the Institutes also be circulated for strict compliance.
