ORDER

Whereas the Hon'ble High Court of Himachal Pradesh vide judgment dated 08.01.2025 in CWP No. 506 of 2025 titled as Gagan Deep Kaur and others Versus State of Himachal Pradesh & another directed that:-

"In view of the above, these writ petitions are disposed of by directing the respondents/competent authority to consider and decide the aforesaid representations of the petitioners in accordance with law within a period of six weeks from today. The order so passed be also communicated to the petitioners. Pending miscellaneous application(s), if any, also to stand disposed of".

And Whereas the Government vide Notification dated 09.08.2012 has introduce Assured Career Progression Scheme on completion of 4,9 and 14 years of service w.e.f 27.08.2009 except such categories of government employees who have been allowed three or more grade structure of pay scale under the Himachal Pradesh Civil Services (Revised Pay) Rules, 1998 and further corresponding conversion under Himachal Pradesh Civil Services (Revised Pay) Rules, 2009. The clarification issued by the Finance Department vide letter No. Fin(PR)B(7)-59/2010 dated 7.7.2014, directed that once an employee has already got three enhancements/financial up-gradations i.e. grant of progression under new or old Assured Career Progression Scheme, or promotion or any other enhancement in his entire service career, thereafter he will not be entitled for placement in next higher grade pay in the new Assured Career Progression Scheme introduced vide FD's instructions dated 9.8.2012.

Now therefore, in view of the facts and circumstances of the case and in compliance to the Hon'ble High Court order in CWP No. 506 of 2025. The petitioners are entitled for three enhancements/financial up-gradations i.e. grant of progression under new or old Assured Career Progression Scheme, or promotion or any other enhancement in his entire service career. Hence the claim of petitioners is rejected.

May inform parties accordingly.
