Kindly find enclosed the copies of the Notifications dated 10.12.2024, 20.12.2024 and 08.01.2025, the contents of which are self explanatory in nature.

Vide the enclosed notifications it was strictly directed to all the heads of the Government Schools that they should conclude their respective annual functions by 31.12.2024 otherwise disciplinary action shall be taken against those who would disobey the said enclosed directions.

On the basis of the above mentioned narration you are requested to provide the following information u/s 6 of the RTI Act 2005:-

1. How many Government Schools have celebrated their annual function in Himachal Pradesh after the deadline of 31.12.2024. Kindly provide their names and names of the Principals/Headmasters of the said schools.
2. Kindly provide the details of the action taken against the heads of those schools that violated the enclosed notifications which were issued by your office. The certified copies of the correspondences should be provided which indicate that the appropriate lawful action has been initiated against those schools that disobeyed the enclosed orders of the Directorate of Higher Education.
3. If no action has been initiated against the said heads of the schools for violating the said enclosed orders then kindly provide the reasons on record for the same on record alongwith the related file notings.
4. Kindly find enclosed an IPO no. 66F 313151 of Rs. 10/- as the requisite fees of the instant RTI application.
5. Kindly correspond through Email/Registered Post to avoid delay.
