**Subject: Regarding display of Sugar Boards in the schools.**

Please find enclose herewith letter No.EDUB-F010/8/2023 (Comp-128975) dated 16-07-2025 and No. EDN-B-GA (17)-6/2025 dated 30-07-2025 along with enclosures received from the Secretary (Education) to the Govt. of HP, on the subject cited above.

In this regard, it is intimated that the World Health Organization (WHO) has raised concerns over the alarming rise of diabetes in India, noting that even children are increasingly being affected by this growing health challenge. To address the growing health concerns, particularly the rising incidence of diabetes among children, the National Commission for Protection of Child Rights (NCPCR) issued an advisory on 6<sup>TH</sup> March 2025, recommending the installation of "Sugar Board" in schools affiliated with all boards, National as well as State. This initiative aims to promote awareness about sugar consumption and encourage healthier the lifestyle choices among students.

In view of above you are requested to issue circular to all the schools affiliated with the **HPBOSE** for implementation of above mentioned directions and direct all the schools to prominently display "Sugar Board" in cafeterias, classrooms and other common areas so that students are regularly exposed to information about the health risks of excessive sugar consumption. A copy of the circular issued, along with detail of the "Sugar Boards" displayed by the schools including photographs any media converge and information on workshops conducted may kindly be shared with NCPCR via email at [ms.ncpcr@nic.in](mailto:ms.ncpcr@nic.in) and a copy of this information should also be sent to the Govt. as well as to the quarter concerned and to this Directorate.
