



In order to streamline and finalise cases of earlier years, applicants and HOIs & INOs of respective institutions are requested to immediately AADHAR seed bank accounts of pending cases so that state share may be transferred into applicants bank accounts. This will be followed by disbursement of central share of scholarship amount. For payment of Central Govt. share, the cut-off dates for clearance of pending cases of scholarship disbursement for both the Post Matric Scholarship Scheme for SC students and Pre-Matric Scholarship Scheme for SCs and Others of last three academic years are as below.

Academic Year	Cut-off Date for accepting State share paid data at NSP for release of Central share
AY 2022-23	31 st October, 2025
AY 2023-24	30 th November, 2025
AY 2024-25	31 st December, 2025

Therefore, all the concerned are requested to take immediate necessary action so that state and central share of scholarship can be transferred through DBT into the bank accounts of the eligible students. Implementing agency will not be responsible, if bank accounts of applicants are not seeded with AADHAR by students/ their parents/institutions, approximately 20 days before above mentioned cut-off dates.
