Regarding option of NPS to OPS beyond period of 60 days vide notification of
Finance Department of HP, dated 04.05.2023.

Sir/Madam,

On the subject matter, it is intimated that, the Department of
Finance(Pension) Govt. of HP vide notification dated 04.05.2023 invited employees to
exercise option for National Pension System(NPS) to Old Pension Scheme(OPS) within 60
days from the date of issuance of these instructions. However, at that relevant time many
employees who were superannuated from their services are not eligible for OPS due to
condition of 10 years of regular service for pensionary benefits under OPS. Hence, no option
was exercised by the employees/retirees at that time.

Later, many petitioners were considered deemed regularized from their
date of initial appointment/joining on contract basis vide this Directorate vide office orders
issued from time to time as per the approval conveyed by the Govt. vide letter No. EDN-C-
E(3)3/2020 dated 15.05.2024 & No. EDNC-E(5)21/2023, dated 23.08.2025 in compliance to
the orders passed by the Hon'ble High Court of HP in various writ petitions on the analogy
of CWP No. 414/2014- titled as Kuldeep Chand Vs State & others alongwith LPA No.
54/2013 titled as State of HP Vs Om Prakash, and all other connected matters.

Further, due to the retrospective regularisation from the initial date of
appointment on contract basis, the employees/retirees became eligible for Old Pension
Scheme thereby completing the qualifying service of 10 years for pensionary benefits. But,
the pensionary cases of the employees/retirees are rejected as they have exercised option
after the prescribed period of 60 days as per notification dated, 04.05.2023.

Thereafter, feeling aggrieved, the incumbents have filed various petitions in
the Hon'ble High Court of HP for fresh option under Old Pension Scheme, the date from
which they became eligible, even after the lapse of two months as was given by the
Department of Finance notification dated, 04.05.2023.

However, In similar cases i.e. CWP No. 7097/2024 titled as Phool Mati Vs
State of HP & others and CWP No. 7138/2025 titled as Lachhman Dass Thakur Vs State of
HP & others the Hon'ble High Court has enabled the petitioners to give fresh option for OPS

even after the lapse of two months as was given by the Finance Department to exercise the option for OPS vide notification dated 04.05.2023.

Thereafter, the matter was taken up with the Govt. vide letter No. EDN(SF)-H(2)B(2)-Option(NPS to OPS), dated 17.09.2025 & 29.09.2025 and Govt. vide letter No. EDN-C-E(3)/3/2020, dated 28.10.2025 directed to apprise factual position of the case to AGHP, that Smt. Champa Devi, JGT(Retd.) is entitled for her pension, as the benefit of deemed regularization has been given to her as per the orders passed by the Hon'ble High Court of HP in CWP No. 414/2014 titled as Kuldeep Chand and others etc as conveyed vide this Department letter of even No, dated 15.05.2024.

Therefore, in view of the above it is hereby directed that in this case and other similar cases the factual position of the case may be appraised to AGHP, that they became entitled for pensionary benefits in lieu of the benefits of deemed regularization as per orders passed by the Hon'ble High Court of HP in CWP No. 414/2014 titled as Kuldeep Chand Vs State & others alongwith LPA No. 14/2013 titled as State of HP Vs Om Prakash, and all other connected matters as these cases stand implemented after the approval conveyed by the Govt. and have attained finality.
