

NOTIFICATION

It is hereby notified that the Department is undertaking the implementation/restructuring of the Complex System in District Kangra. Accordingly, all Complex Heads-cum-Principals of Government Senior Secondary Schools in District Kangra are directed to examine the existing configuration of their respective Complex Schools and to submit restructuring proposals, wherever necessitated, in strict conformity with the instructions detailed herein.


In cases where Elementary (Primary & Middle) and Secondary (High and Senior Secondary) Schools are functioning within the same premises but are presently attached to different Complex Schools, such institutions may submit a proposal for their placement under a single, common Complex. Further, where any institution is presently attached to a Complex School different from the school exercising DDO powers for that institution, a proposal for restructuring may be submitted so as to align the institution with the school where its DDO powers vest, subject to the condition that the proposed school shall constitute the nearest feasible option.

In situations where the nearest Government Senior Secondary School does not currently hold DDO powers, the concerned institution may propose the conferment or transfer of DDO powers in favour of the nearest GSSS deemed appropriate. The Heads of institutions falling under existing Complex arrangements may also forward restructuring proposals, wherever justified. However, such proposals shall be considered only if they bear the joint countersignatures of the concerned BEEO and BPO, certifying administrative feasibility, geographical correctness, and conformity with departmental norms. Proposals not duly recommended with the combined signatures of both the BEEO and the BPO shall not be entertained.

During the restructuring process, the concerned education blocks and the centres of schools may also be changed, subject to the condition that the newly proposed Complex School is the nearest and most administratively feasible option for the institution concerned.

A period of seven (07) days from the date of issuance of this Office Order is hereby accorded for submission of restructuring proposals. All Complex Heads, Principals, BEEOs, and BPOs are directed to ensure meticulous compliance and timely submission so as to facilitate the smooth and efficient restructuring of the Complex System in District Kangra. The Heads of the Complex are further directed to examine the feasibility of such institutions and to submit proposals strictly in the prescribed proforma attached herewith within the stipulated period of seven days positively.
