All Deputy Commissioners through concerned Block Development Officers are directed to ensure the timely constitution of these Committees at the Panchayat level and provide necessary administrative support for their effective functioning.

The Committees shall convene meetings at monthly basis to:

- Assess and review the local situation regarding drug abuse;
- Monitor and gather intelligence on Heroin/Chitta-related activities, including identification of peddlers, consumers, addicts, or any suspicious activities, and facilitate timely sharing of this information with local police station or other law enforcement agencies in the state;
- Conduct sensitization and awareness programmes in schools, communities, and public spaces;
