In view of Hon'ble High court of HP orders in various court cases and approval conveyed by the Secretary (Education) to the Government of H.P. vide letter No. EDUC-E05/7/2025 dated 01.10.2025, the judgment qua the petitioners Lecturers (School New) is hereby implemented subject to the final outcome of I.P.A. The Principal of concerned schools where these Lecturers (School New) presently working are directed to fix their pay for the period, they served on contract basis at the minimum of revised pay band+Grade Pay alongwith such hike, to which, they are entitled to in terms of revised notification from 01.01.2016 to till their regularization as per Hon'ble High Court orders.
