In this regard, it is informed that the Special Leave Petition (Civil) No. 20496/2024 titled State of Himachal Pradesh & Others vs. Satya Devi, along with connected matters, is presently pending consideration before the Hon'ble Supreme Court of India. The said matter arises out of the judgment dated 28.05.2024 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 2274/2021 titled Satya Devi vs. State of H.P., concerning the issue of retirement age of Class-IV employees, i.e., 60 years as against 58 years.

In view of the above, you are hereby requested to bring this matter to the notice of all Class-IV employees under your administrative control. It may also be conveyed that any employee (serving or retired), who is desirous of participating in the aforesaid proceedings, may do so by filing an appropriate application for impleadment before the Hon'ble Supreme Court of India.

Further, you are requested to ensure that the above information is brought to the notice of all concerned employees under your control without fail.


