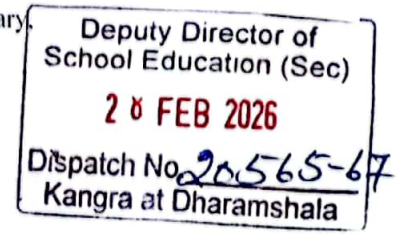

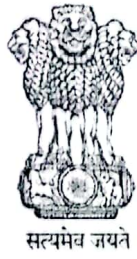

Sir/Madam,

This is in continuation to this office earlier communication & as per the directions received from the Directorate of NSS, New Delhi, Ministry of Youth Affairs & Sports, Government of India vide their letter no. P/32/NSS/2025/DTE/3515-3530 dated 19th February, 2026 on the subject cited above. **It is reiterated that the 100% registration of NSS volunteers and NSS Program Officers of NSS Units allocated in Universities/Colleges/Schools under your jurisdiction should be onboarded on the MY Bharat Portal on or before 31st March, 2026.** This may be accomplished through the special registration drive and outreach activities within their respective institutions. Participation in the above activity shall be duly recognized and counted towards NSS Credit Hours as part of the volunteer's engagement and contribution.

The registration process is essential for seamless integration of NSS volunteers on the MY Bharat portal and for enabling access to various opportunities, including Experiential Learning Programmes (ELPs), Volunteer for My Bharat opportunities, and other engagement modules. **It may be ensured that the awareness is created at the institutional level about the portal and its benefits, registration of all NSS Volunteers and NSS POs is completed on or before 31st March, 2026, without fail, and periodic monitoring is carried out to track registration progress.** Additionally, outreach activities such as orientation sessions should be organized at both the institutional and district levels to maximize registration and participation of NSS Volunteers as youth on the portal.

You are well aware of the gravity of this subject, so **you are requested to kindly issue necessary directions in writing to all the Universities/Colleges/Institutions/Schools through their NSS Programme Coordinators and Principal/Head of Institutions** under your jurisdiction to ensure that every enrolled NSS volunteer and NSS Programme Officer **is duly registered on the MY Bharat Portal (<https://mybharat.gov.in>) on or before 31.03.2026, without fail.** Further, it is requested to submit **a compliance report and progress made in this regard to this NSS Regional Directorate by 25.03.2026** for onward submission to the Ministry/Directorate of NSS, New Delhi as the same would be reviewed by the Ministry.

The matter may be treated as **Most Urgent** and accorded **Top Priority**.
