Subject: - **Submission of Estimates of schools damaged During Disaster-2025-Most Urgent.**

Memo,

This is with reference to worthy Director Office letter No. EDN-H (DSE)(4)-2025-Disaster dated 25th Feb, 2026 on the subject cited above.

In this connection, the Higher Authorities has observed that the estimates of repair, reconstruction and restoration work for the schools that damaged during disaster-2025 have not yet been submitted by your schools to this office so far. And this office has also communicated about said matter through e-mail, whatsapp and another way of communication.

In this connection, you are directed to prepare the need based estimates from Govt, Executive Agencies and submit to this office with in two days through special messenger alongwith following information; so that further necessary action could be taken accordingly:

1. Class/Category wise total enrolment of the students in the school
2. Detail of available/existing accommodation of the school.
3. Provide the need based estimats duly prepared by the Govt. Executive Agency.
4. Provide a copy of the resolution passed by the SMC concern duly signed by the concerned Head of Institution.
5. Provide the Revenue report and at least three photographs of damaged portion of school buildings etc.


