

**Subject: - Regarding Plying of school vehicle without Valid documents  
i.e fitness, permit etc.**

Sir/ Madam,

On the subject cited above, It is submitted that during the screening of online data of the school buses, it has been found that some of the school buses registered at various sub division in Distt. Kangra are plying without valid fitness, permit, insurance & taxes etc, which is matter of serious concern and violation of the rule- 73 A of Himachal Pradesh Motor Vehicle Rules 1999 & strict action is required to be taken against the vehicles under Motor Vehicle Act 1988/ CMVR 1999, made there under.

You are therefore, requested to issue strict directions to all the owners of schools affiliated with HPBOSE/ CBSE/ ICSE not to ply any school bus without valid document and the safety guidelines issued by the TPT Department regarding school children and if any bus is found plying w/o fitness permit, insurance can be impounded under the provisions of CMV ACT 1988/ CMV 1999 and HPMV Taxation Act 1972 ( amendment upto date) for which the Principal will be solely responsible.
