I am directed to refer to the subject cited above and to say that as you are well aware that the preparations for conduct of Census 2027 are at advanced stage and for the process of Census work, appointment of approximately 18,600 Enumerators & Supervisors, 420 Field Trainers and 20 Master trainers has also commenced and training of these Census functionaries is also going on across the State.

The State Level Census Coordination Committee in its meeting held under the Chairmanship of Worthy Chief Secretary to the Government of Himachal Pradesh has decided vide decision No 3 of the minutes of the meeting that 20 Master Trainers & 420 Field Trainers appointed for Census 2027 may not be deputed for upcoming Panchayat Election in the State since Census data is the primary source, for planning, formulation of policies. Economic Growth and Economic Development of the State. This Census data is to be extracted with utmost care and successfully and this is possible if these functionaries are not deputed elsewhere during the whole process of Census 2027.

It is, therefore, requested that necessary instructions may kindly be issued to all the concerned Officers/officials under your jurisdiction ensuring that Master Trainers and Field Trainers may not be deputed for upcoming Panchayat Election, please.
