Subject: Non compliance of guidelines regarding Restructuring of School  
Complex.

Memo,

As you are well aware that the aim of restructuring of School Complex System is to improve learning outcomes, strengthening school administration, and aligning the schooling system with the objectives outlined in the National Education Policy (NEP) 2020 in the State. Accordingly, the Government of Himachal Pradesh issued guidelines on dated 23.09.2025 to ensure smooth functioning of the School Complex System, address gaps, remove inconsistencies, and enhance coordination.

However, it has come to the notice to the undersigned that role and responsibilities prescribed in these guidelines are not being implemented effectively. As Instructions issued by DDSEs particularly from the DDSEs( Elementary ) are being overlooked or ignored by the BPOs and principals. Such as details of Court cases, establishment related issues or Vidhan Sabha questions are not being submitted within a stipulated time by the BPOs as well as Ministerial staff working in BPO offices. This lack of adherence is affecting the smooth functioning and intended outcomes of the restructuring process. The restructuring initiative aims to create a more efficient, inclusive, and resource-optimized educational environment. However, without proper compliance with the prescribed roles and responsibilities, the objectives of this initiative can not be achieved.

Therefore, all the BPOs/Principals/Headmasters/BRCs are hereby directed to strictly adhere to the guidelines and instructions issued from time to time by the concerned DDSEs . further, directed to ensure timely submission of the required information at block and complex level. Any negligence in this regard will be viewed seriously and may cause appropriate action.
