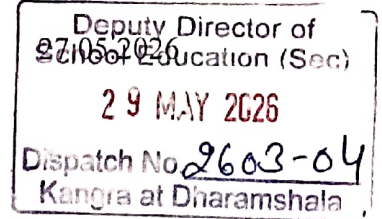

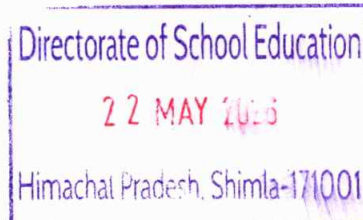



The Pradhan Mantri Rashtriya Bal Puraskar (PMRBP) is a prestigious national award conferred by the Government of India to recognize exceptional achievements of children in various fields. Instituted to honor meritorious young individuals, the award is given under six categories: Bravery, Social Service, Environment, Sports, Art & Culture, and Science & Technology. Children below the age of 18 years (as of 31st July 2026) who have demonstrated excellence and outstanding contributions in these fields are eligible to be nominated.

2. To ensure a broad-based selection process, nominations for PMRBP are invited from all Ministries/Departments of the Government of India, State Governments, Union Territories, and other relevant institutions. The nominations/recommendations for PMRBP will be received only online through the Rashtriya Puraskar Portal (<https://awards.gov.in>) designed for this purpose.

3. It has been observed that while a large number of nominations are received each year, many deserving children may go unnoticed each year as they do not seek public attention. It is, therefore, requested to make concerted efforts in identifying such children whose excellence and achievements deserve to be recognized and make suitable nominations in their favour.

4. In view of the above, you are requested to kindly send suitable nomination for the PMRBP. Further, a dedicated login ID has been created for your State/UT to facilitate nominations (details enclosed). While finalizing recommendations, the following aspects may be ensured:


- i. The recommended children are exceptionally deserving of national level award. Public service as part of their achievements is desirable.
- ii. Special efforts are made to identify talented children from among girls, weaker sections, SC/ST communities, and divyang persons.

5. The online nominations/recommendations for the PMRBP have started from 1st April, 2026 and the last date for nominations is 31st July, 2026. The cut-off date may please be strictly adhered to as nominations/recommendations received only during 1st April, 2026 to 31st July, 2026 will be considered. You are earnestly requested to consider nominating such children whose outstanding achievements and contributions merit recognition under the Pradhan Mantri Rashtriya Bal Puraskar.
