It is specifically requested that schools which were damaged during monsoon-2025 and have already been reported should not be included in these reports. Only fresh cases of damage occurring during monsoon 2026 are to be reported.

You are directed to submit the daily disaster loss report regularly and ensure that no report is missed.. This may be treated as Most Urgent and strict compliance of this direction may be ensured.
