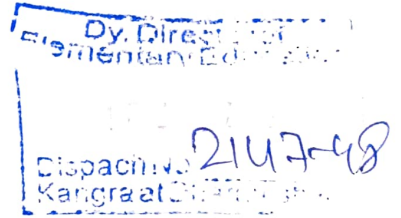

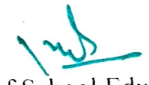
Regarding CWPOA No. 3435/2020 titled as Satish Kumar & ors Vs State of H.P. & others alongwith CWPOA No. 6850/2020 titled as Milat Ram & ors Vs State of H.P. & others and conneted matter.

Memo,

In reference to the subject cited above, it is informed that Director of School Education, Shimla vide office order No. EDN(SE)H(2)B(2)3435/2020-CC dated 20-06-2026 has ordered in compliance with the judgment passed by the Hon'ble High Court of H.P. in LPA 836/2025 that, "those petitioners/non-petitioners whose names were recommened by the Secretary, HPSSSB, in the years 2002 and 2012, but who were subsequently appointed on regular basis in the years 2006 and 2007 on the recommendations of HPSSSB, Hamirpur, pursuant to a different advertisement issued in the year 2005, shall not be entitled to the benefits extended to the petitioners in CWPOA No. 3435 of 2020, titled Satish Kumar & ors Vs State of H.P. & others alongwith CWPOA No. 6850/2020 titled as Milat Ram & ors Vs State of H.P. & others , and other connected matters as their appointments were made through a separate and independent recruitment process and do not fall within the category of employees covered by aforesaid judgments. It is further ordered that, in case any benefits have already been extended to any incumbent falling within the above category, the same shall stand withdrawn with immediate effect."

Keeping in view of above, it is hereby directed that such benefits may not be extended to any person/persons posted in your respective schools, and such benefits if any have been extended to any incumbent, same shall be withdrawn with immediate effect.

Further, it is also directed that if any benefit of ACPS to any officials has been granted in contravention of aforesaid order, intimation in this regard be submitted to this office within 15 days so that same could be withdrawn accordingly. Failure to which concerned Principal/DDO personally will be held responsibility for recovery, if any in future. Besides above the cases for ACPS of persons in said judgments be submit to this office strictly in accordance with above orders. Ensure strict compliance.
