per Finance Department OM No. Fin-F-(F)-1-1/2025, dated 01.07.2026.

Please refer to the Finance Department's Office Memorandum No. Fin-F-(F)-1-1/2025, dated 01st July, 2026 regarding "Various issue(s) related to 'Compassionate Employment Policy of the Government' - Latest instruction(s) thereof" (copy enclosed).

In this regard, it is intimated that as per the above mentioned OM, the Government has decided to re-consider/re-examine the compassionate employment cases, which were earlier rejected solely on the ground of non-indigency, as a one-time measure. The eligible dependents shall submit their fresh applications/cases to the concerned Head of Department by 31.12.2026.

You are, therefore, directed to widely circulate the contents of the above referred Finance Department OM dated 01.07.2026 among all concerned and accept fresh case with all relevant documents from the eligible dependents whose cases were rejected earlier solely on the ground of indigency. Further, get the indigency of each such case assessed afresh as on the date of receipt of the new application, as per the prevailing policy, place such cases before the Departmental Committee constituted for this purpose and obtain its recommendations and thereafter, forward all such eligible cases, complete in all respects along with the recommendations of the Committee to this Directorate within the stipulated time for further necessary action.

It is reiterated that only those cases which were rejected solely due to non-indigency are to be considered under this one-time relaxation. Cases rejected on any other ground shall not be entertained.

The entire exercise must be completed on top priority so that eligible cases can be processed and submitted to the Government well before the cutoff date.

This may be treated as MOST URGENT.

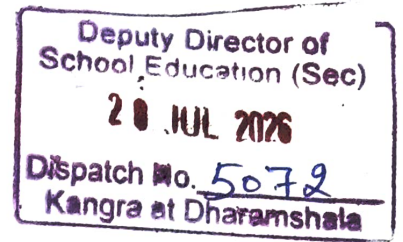
